

#### **Presentation for Agencies/ Institutions for VIGYAN DHARA - 4305**

#### Step-By-Step FOR AGENCIES WHO HAVE THEIR ZERO BALANCE SUBSIDIARY ACCOUNT (ZBSA) IN SCB (UNION BANK OF INDIA)

i. **Settlement of Advances –** Implementing Agencies (IA) having unsettled advances need to first settle the advances against existing schemes 1817, 1819 & 3237 before on-boarding on TSA Hybrid model.

ii. Deactivating The Earlier Scheme – The IA Admin will go on their PFMS and Deactivate the earlier Scheme 1819 (As instructed in Slide 8). After this action is taken by IA Admin, also be reminded to see the IA available for deactivation in their own login ID. The DST PD will then approve the deactivation request raised by IA. The IA should inform the respective Program Officer along with the Agency Code for approving the deactivation request on PFMS.

**iii. KYC and Account Renaming-** IAs already having ZBSA in Union Bank of India consisting Scheme Name ITDD/1819 added in their Account Name, must change and update the name of the Existing Account along with getting KYC procedure done for the same. The updated Account name **must** have name of new scheme i.e Vigyan Dhara as suffix to the institution name. Sample: **[Eg: \*Institution Name\*\_Vigyan Dhara]** 

**iv. PFMS Mapping -** IAs who are on PFMS will then add their bank account on PFMS with the new funding agency and scheme i.e. **TDB (unique code (TDBDST)** for **Vigyan Dhara (4305)**.

v. **Forwarding to CNA DST For Approval -** Thereafter, IAs need to forward the Bank mandate form signed by Head of Institution and countersigned by the Bank Branch Manager to CNA-TDB DST for approval. The duly signed Bank Mandate form is to be sent via email to CNA-TDB DST [Office-clerk3@tdb.gov.in ; accountofficer@tdb.gov.in] along with Screenshots from the PFMS Portal indicating the submission of Account Information in PFMS.




## **Role of Implementing Agencies:**

- IAs having unsettled advances need to first settle the advances against existing schemes 1817, 1819 & 3237 before on-boarding on Hybrid TSA.
- IAs already having ZBSA in Union Bank of India to do kyc for existing account to update the name of new scheme suffix to institution name Vigyan Dhara as the case may be.
- IAs will add bank account with new scheme and funding agency will be TDB for Vigyan Dhara and NII for Bio RIDE. Thereafter, IAs to forward mandate form to CNA-TDB /NII as the case may be.
- IAs not having any settlement pending for committed liability / advances need to start De-activation of existing ZBSA of UBI & ICICI from schemes 1817, 1819 & 3237 before on-boarding on TSA Hybrid.

#### 3/3 Implementing Agencies – Roles & Responsibilities

- i. Agencies should inform the banks whenever they register/convert their Savings/ZBSA accounts so as to enable the banks for enhancing / restricting the functions of those accounts.
- ii. In the case of conversion of one account type to another type, all balances in the account should be cleared or transferred out beforehand. No previous balances should remain in the account after the conversion.
- iii. Agencies should not use the ZBS account for any receipt of fund. The purpose of ZBSAs is to link it to the savings account for the execution of payment only the scheme for which the account is opened and mapped.
- iv. Agencies must regularly and promptly reconcile balances and financial limits with banks and also report any discrepancies to banks for immediate corrective actions.
- v. As soon as the funds gets transferred to top level agency corresponding to claims raised by below level agencies, PFMS will push the corresponding payment files through commercial bank of child agencies.
- vi. Funds in ZBSA of child agencies corresponding to failures to be transferred back to savings account pertaining to recipient agency i.e., agency at start of hybrid level.






